### Apply to register a Premises as a Dwelling

You should fill in this form if you wish to apply to Uisce Éireann to register a Premises as a Dwelling. You must fill out this application form completely, truthfully and to the best of your knowledge. If completing this form by hand, please use BLOCK CAPITALS and black ink.

**Note**: We can only accept this application if you complete all sections of this form. When you sign at the end, you will need a witness when you sign and they need to sign too.

When we receive your completed and signed application form, we will review the information you have given us. We have the right to carry out site investigations, or ask you for more information, or both, so we can verify any of the information you have given us.

We will let you know if your application has been successful as soon as we can.

We have the right to change the type of water meter installed in a premises.

If we approve and accept your application but then, at a later date, decide that the Premises is not a Dwelling, we may change the classification. This would mean we could send invoices (and collect payment) for providing our services to the Premises during the time that they were incorrectly registered as a Dwelling.

In this form we have used capital letters for the following terms.

- Premises mean the building where we are providing water services
- Dwelling means a Premises a person lives in as their place of Private Residence (whether or not it is their Principal Private Residence)
- Private Residence means a Premises where the occupiers live and have the right to exclude others
- Non-Domestic Premises means any Premises that is not a Dwelling.

We will review your application and may contact you for more information. We will contact you in relation to your application in due course.
