

Pipe Maintenance Responsibility

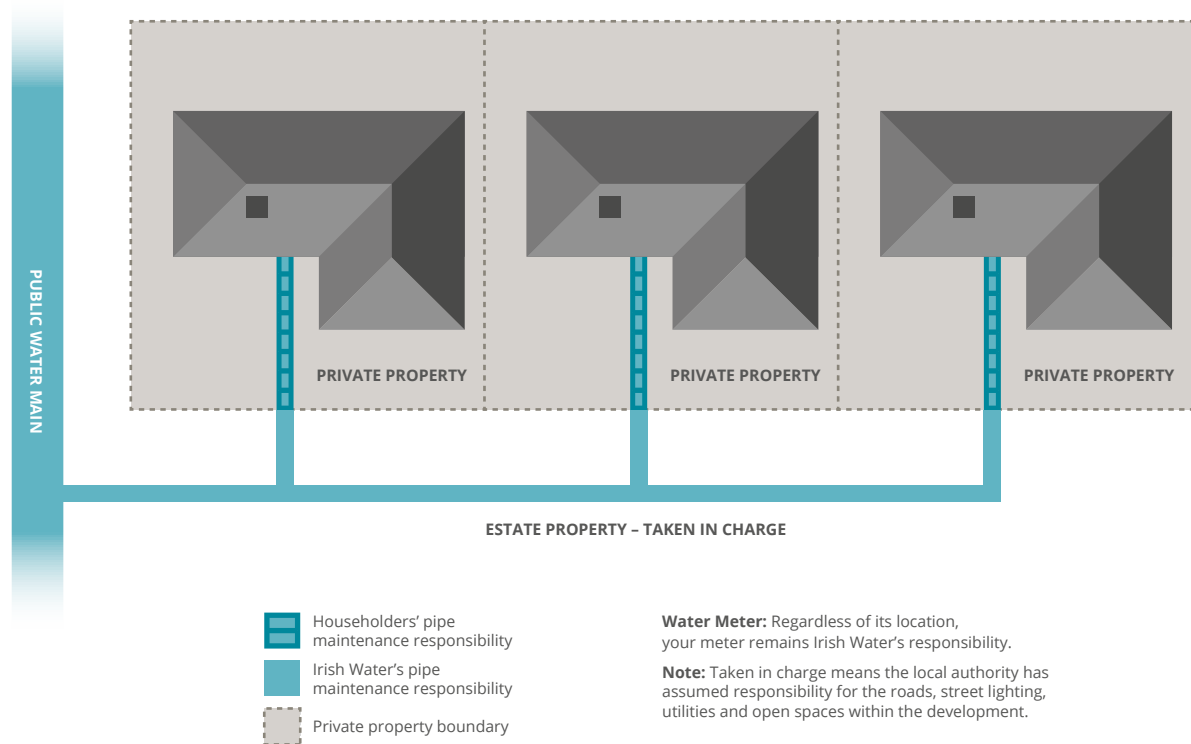

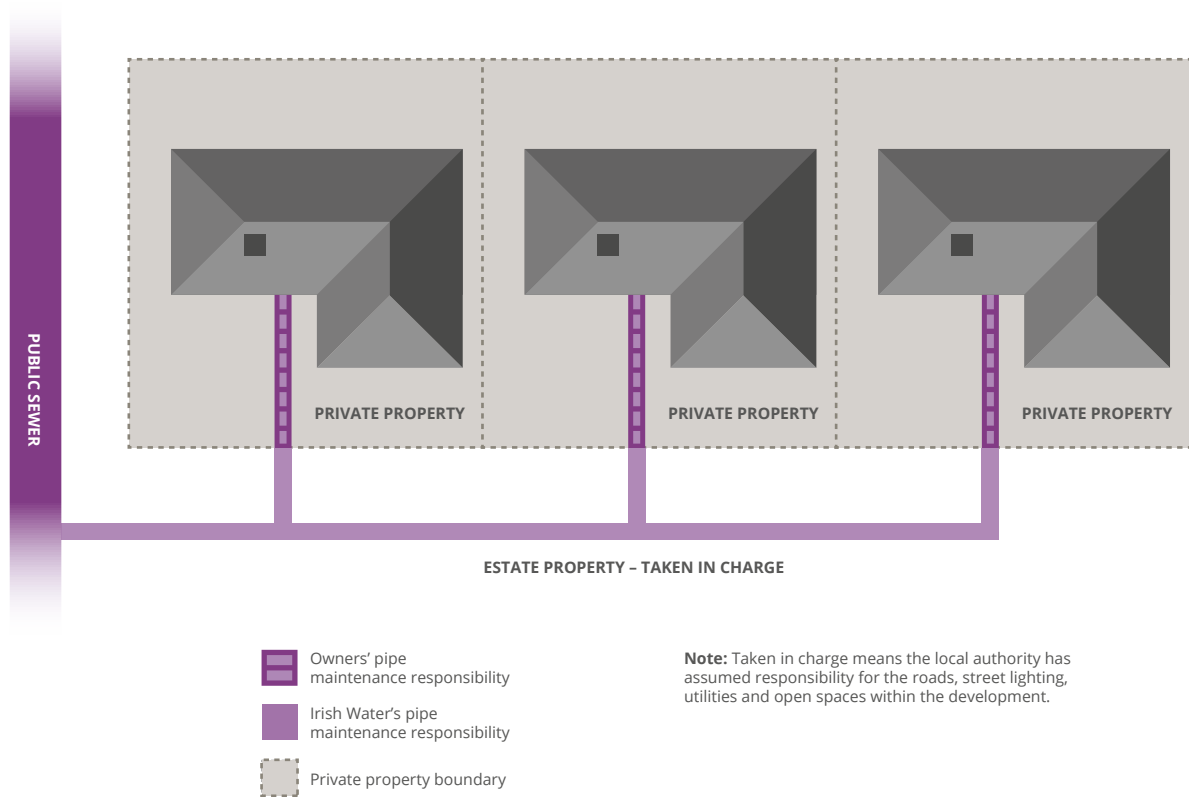

PRIVATE RESIDENTIAL ESTATE WATER SUPPLY – TAKEN IN CHARGE



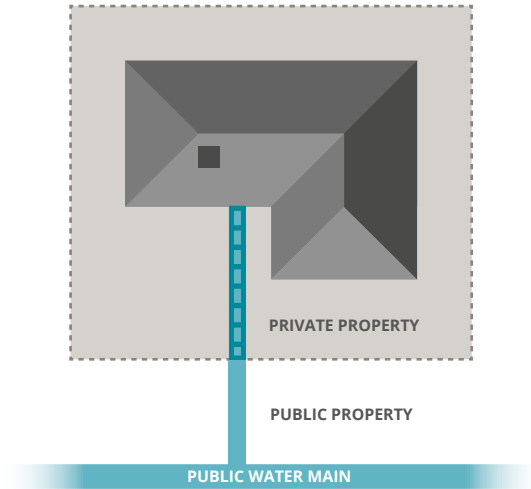

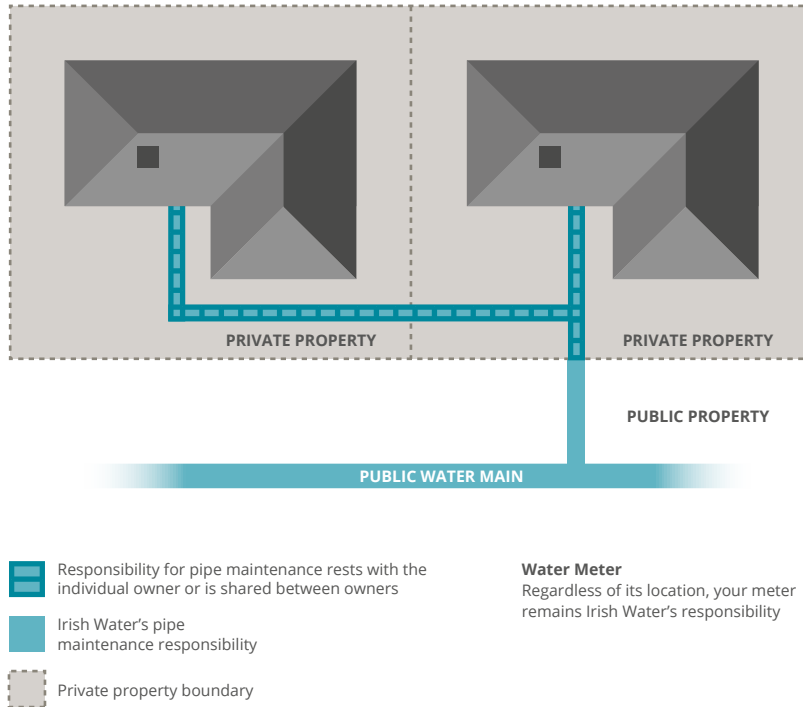

SINGLE DETACHED PROPERTY WASTEWATER



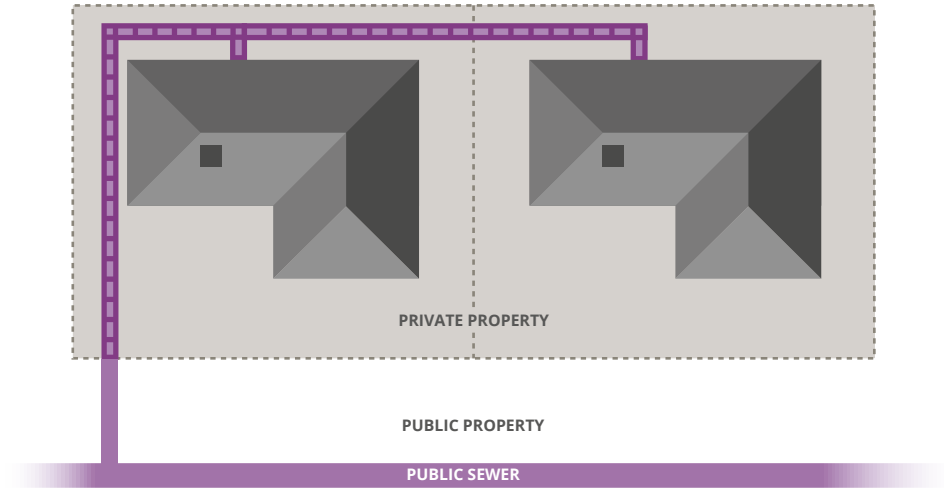

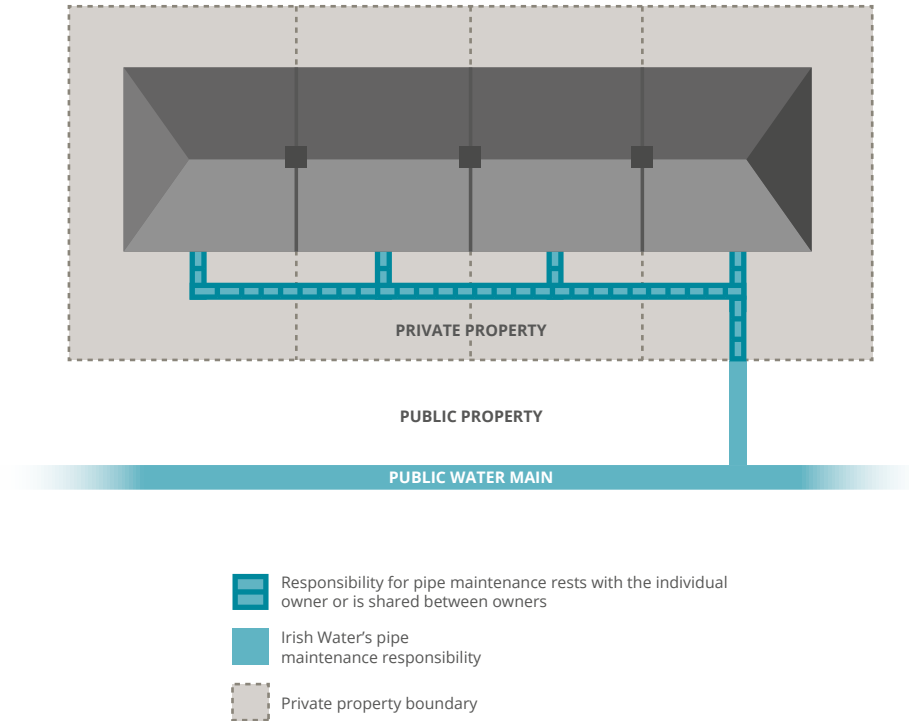
DETACHED PROPERTIES SHARED WASTEWATER

-  Private property boundary

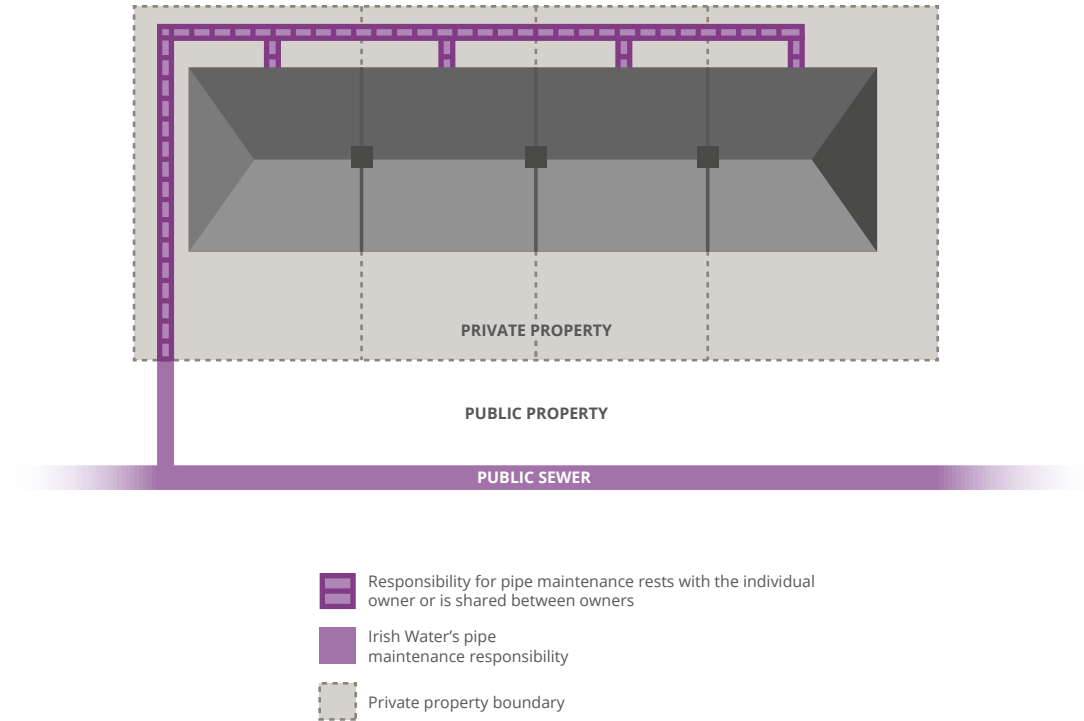

TERRACED PROPERTIES SHARED WATER SUPPLY



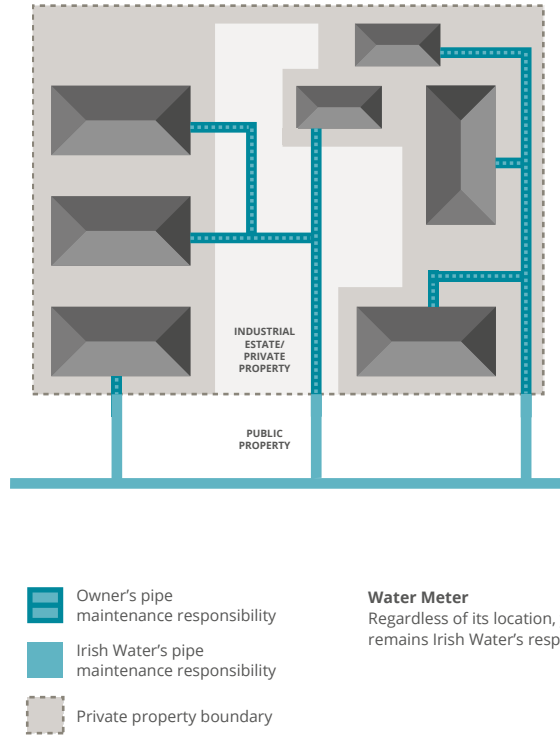

TERRACED PROPERTIES SHARED WASTEWATER CONNECTION



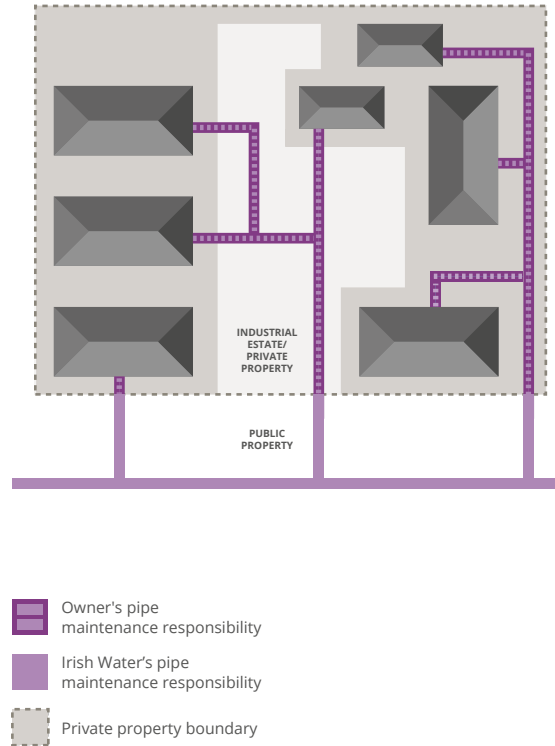
