Significance of Results:

The WWTP discharge was compliant with the ELV's set in the wastewater discharge licence.

The discharge from the wastewater treatment plant does not have an observable impact on the water quality.

The discharge from the wastewater treatment plant does not have an observable negative impact on the Water Framework Directive status.

Taking on board the plants compliance with the ELVs, the 2018 coastal ambient monitoring data and a review of the 2018 EPA Beaches.ie data it is not considered that the wastewater treatment plant is impacting on the bathing water designations nearby.

3 OPERATIONAL REPORTS SUMMARY

3.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

Greystones South has achieved an Excellent Water Quality rating for five consecutive years 2014 to 2018. Annual water quality ratings are generally calculated using monitoring results over a four-year period and are assessed against stringent bacterial limits to protect bather health.
