# 1 EXECUTIVE SUMMARY AND INTRODUCTION TO THE 2018 AER

This Annual Environmental Report has been prepared for D0152-01, Mountmellick, in Laois in accordance with the requirements of the wastewater discharge licence for the agglomeration. Specified reports are included as an appendix to the AER as follows:

## **Annual Statement of Measures**

The preliminary treatment stage of this plant has been upgraded with a new fine screening and grit removal system installed. Fine bubble diffused aerators (FBDA) have replaced the surface aerators. The installation of FBDA was completed in September 2018.

A summary of influent monitoring for the treatment plant is presented in below. This monitoring is primarily undertaken in order to determine the overall efficiency of the plant in removing pollutants from the raw wastewater.

### Significance of Results:

The annual mean hydraulic loading is less than the peak Treatment Plant Capacity as detailed further in Section 3.2. The annual maximum hydraulic loading is greater than the peak Treatment Plant Capacity as detailed further in Section 3.2. The design of the wastewater treatment plant allows for peak values and therefore the peak loads have not impacted on compliance with Emission Limit Values.

#### Significance of Results:

The WWTP discharge was compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results did not meet the required EQS for Ammonia and Ortho-P d/s of the WWTP. Where the ambient monitoring results meet the EQS this relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

A deterioration in water quality has been identified in terms of Ortho-P and to a lesser extent Ammonia, however, it is not known if it or is not caused by the WWTP. Other potential causes of deterioration in water quality in the area are unknown.

The discharge from the WWTP has no observable negative impact on the Water Framework Directive status. The status is Moderate both u/s and d/s of the WWTP discharge.

# 3.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:
