Significance of Results:

The annual mean hydraulic loading is less than the peak Treatment Plant Capacity as detailed further in Section 3.2. The annual maximum hydraulic loading is greater than the peak Treatment Plant Capacity as detailed further in Section 3.2. The design of the wastewater treatment plant allows for peak values and therefore the peak loads have not impacted on compliance with Emission Limit Values.

2.3.2 Ambient Monitoring Parameter Summary - GRANARD WWTP

Significance of Results:

The WWTP discharge was compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results did not meet the required EQS. Where the ambient monitoring results do not meet the EQS this relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

The Camlin-Rinn Water Management Unit Action Plan (WMUAP) identifies the WWTP in Granard as a point pressure on the River Rhine catchment. There is no upstream monitoring point. Downstream of the discharge is Poor status.

The plant is compliant with the ELVs. It is unknown if it is contributing to the downstream Poor status.

3 OPERATIONAL REPORTS SUMMARY

3.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.
