Significance of Results:

The WWTP discharge was not compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results meet the required EQS.

The parameters which exceeded the EQS and may be causing an are: Not applicable.

Any other known impacts: For reasons of access and Health & Safety, downstream samples are being taken on the Moynalty river of which the Mullagh Lough Stream (which the WWTP discharges into) is a tributary. Upstream samples are taken upstream of the WWTP from the Mullagh Lough Stream. Very low flow in Mullagh Lough Stream at upstream monitoring location due to weather conditions in summer 2018.

2.1.4 OPERATIONAL PERFORMANCE SUMMARY

2.1.4.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:
