Cause of Exceedance(s):

There is not sufficient treatment capacity to meet the WWDL ELVs.

Significance of Results:

The WWTP is not compliant with the ELV's set in the Wastewater Discharge Licence. There were 12 samples which exceeded the ELV for BOD, 3 of which were above Condition 2 interpretation. There were 10 samples which exceeded the ELV for Ammonia, 6 of which were above Condition 2 interpretation. Exceedances for both BOD and Ammonia are as a result of the WWTP being overloaded. The impact on receiving water is assessed further in Section 2.3.

2.3 Ambient monitoring summary

A summary of monitoring from ambient monitoring points associated with the wastewater discharge is provided in the sections below. For discharges to rivers upstream (U/S) and downstream (D/S) location data is provided. For other ambient points in lakes, coastal or transitional waters, monitoring data from the most appropriate monitoring station is selected.

2.3.2 Ambient Monitoring Parameter Summary - STAMULLEN WWTP

The results for ambient results and / or additional monitoring data sets are included in the Appendix 7.1 - Ambient Monitoring Summary.

Significance of Results:

The WWTP discharge was not compliant with the BOD and Ammonia ELV's set in the wastewater discharge licence.

The ambient monitoring results did not meet the required EQS for Ortho-P u/s and d/s of the WWTP. Where the ambient monitoring result does not meet the EQS this relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

Ambient monitoring results indicate an increase in Ortho-P d/s of Stamullen WWTP. However, the discharge from the WWTP was compliant with the licence ELV throughout 2018. Other causes of deterioration in water quality in the area are unknown.

The discharge from the wastewater treatment plant does not have an observable impact on the water quality.

The discharge from the wastewater treatment plant does not have an observable negative impact on the Water Framework Directive status. The Water Framework Directive status is Poor approx. 35, d/s of the u/s sampling point.

It is noted that consistent achievement with the ELVs would benefit the quality of the receiving water.

3 OPERATIONAL REPORTS SUMMARY

3.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:
