1 EXECUTIVE SUMMARY AND INTRODUCTION TO THE 2018 AER

This Annual Environmental Report has been prepared for D0289-01, Durrow, in Laois in accordance with the requirements of the wastewater discharge licence for the agglomeration. Specified reports are included as an appendix to the AER as follows:

Significance of Results:

The WWTP discharge was compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results meet the required EQS. Where the ambient monitoring results meets the EQS this relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

The discharge from the wastewater treatment plant does not have an observable negative impact on the water quality.

The discharge from the WWTP has no observable negative impact on the Water Framework Directive status.

The WWTP was compliant with the licence specified ELV and therefore based on this it not considered that the Durrow WWTP is impacting upon drinking water abstraction approximately 9.5km d/s of the primary discharge point on the Nore River. A risk assessment for the protection of the downstream drinking water abstraction point was appended to the 2017 AER.

The WWTP was compliant with the licence specified ELV and therefore based on this it not considered that the Durrow WWTP is impacting upon the downstream pearl mussel population.

3 OPERATIONAL REPORTS SUMMARY

3.1 Treatment Efficiency Report

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.
