2.1.4 OPERATIONAL PERFORMANCE SUMMARY - DOWNINGS WWTP

2.1.4.1 Treatment Efficiency Report - DOWNINGS WWTP

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.
