Significance of Results:

The WWTP discharge was not compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results does not meet the required EQS. The EQS relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

Based on ambient monitoring results a deterioration in Ammonia and ortho-phosphate , concentrations downstream of the effluent discharge is noted.

A deterioration in water quality has been identified, however it is not known if it or is not caused by the WWTP.

Other causes of deterioration in water quality in the area are: unknown pressures. The WWTP discharges into the Mullagh Lough Stream and the upstream monitoring point is on this water body. The Mullagh Lough Stream is a tributary of the Moynalty river and the downstream monitoring location is on the Moynalty river downstream of the confluence. D/s annual means for Ammonia and Ortho-Phosphate were higher than the upstream means however it is difficult to attribute this to the WWTP discharge.

The discharge from the wastewater treatment plant does have an observable negative impact on the Water Framework Directive status.

2.1.4 OPERATIONAL PERFORMANCE SUMMARY - MULLAGH WWTP

2.1.4.1 Treatment Efficiency Report - Mullagh WWTP

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:

Nominal design capacities can be based on conservative design principles. In some cases assessment of existing plants has shown organic capacities significantly higher than the nominal design capacity. Accordingly plants that appear to be overloaded when comparing a collected peak load with the nominal design capacity can be fully compliant due to the safety factors in the original design.
