# **1 EXECUTIVE SUMMARY AND INTRODUCTION TO THE 2022 AER**

This Annual Environmental Report has been prepared for D0001-01, Portlaoise, in Laois in accordance with the requirements of the wastewater discharge licence for the agglomeration. Specified reports where relevant are included as an appendix to the AER.

## **1.1 ANNUAL STATEMENT OF MEASURES**

A summary of any improvements undertaken is provided where applicable.

There were no capital works, significant changes or operational changes undertaken in 2022.

Stage 3 of the Drainage Area Plan (Wastewater Network Risk Assessment and Needs Identification) has been completed for the Portlaoise agglomeration. This assessed risks and identified needs for the agglomeration in the present-day scenario and across the 25-year horizon. The DAP encompassed both Storm Water Overflow (SWO) and network assessments.

Uisce Éireann are currently in the process of appointing an ESP to undertake Stage 4 of the Drainage Area Plan (Strategy, Optioneering and Future Solutions Concept Design). The Stage 4 scope has specifically targeted; schemes to relieve flooding in central areas of the town, areas to efficiently target surface water removal within the network, SWO upgrades (including screening) for non-compliant/unscreened SWOs.

As concept solutions are developed these will be workshopped and make their way onto Uisce Éireann's capital investment plan to be prioritised and progressed by Infrastructure Delivery, as appropriate.

#### Significance of Results:

The annual mean hydraulic loading is less than the peak Treatment Plant Capacity. The annual maximum hydraulic loading is greater than the peak Treatment Plant Capacity. Further details on the plant capacity and efficiency can be found under the sectional 'Operational Performance Summary'. The design of the wastewater treatment plant allows for peak values and therefore the peak loads have not impacted on compliance with Emission Limit Values.

#### Significance of Results:

The WWTP discharge was compliant with the ELV's set in the wastewater discharge licence.

The ambient monitoring results do not meet the required EQS at the upstream and the downstream monitoring locations. The EQS relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

Based on ambient monitoring results a deterioration in BOD & Ammonia concentrations downstream of the effluent discharge is noted.

A deterioration in water quality has been identified, however it is not known if it is or is not caused by the WWTP.

As per the 3rd Cycle Draft Barrow Catchment Report (HA 14), the significant pressures on the At Risk TRIGOUE\_020 waterbody are Urban Runoff & Urban Waste Water.

The discharge from the wastewater treatment plant does not have an observable negative impact on the Water Framework Directive status.

## 2.1.4 OPERATIONAL PERFORMANCE SUMMARY - PORTLAOISE WWTP

#### 2.1.4.1 Treatment Efficiency Report - Portlaoise WWTP

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:

In some cases assessment of existing plants has shown organic capacities significantly higher than the nominal design capacity. Accordingly plants that appear to be overloaded when comparing a collected peak load with the nominal design capacity can be fully compliant due to the safety factors in the original design.
