2.1 KILDALKEY WWTP - TREATED DISCHARGE

2.1.1 INFLUENT MONITORING SUMMARY - KILDALKEY WWTP

A summary of influent monitoring for the treatment plant is presented below. This monitoring is primarily undertaken in order to determine the overall efficiency of the plant in removing pollutants from the raw wastewater.

Significance of Results:

The annual mean hydraulic loading is less than the peak Treatment Plant Capacity. The annual maximum hydraulic loading is greater than the peak Treatment Plant Capacity. Further details on the plant capacity and efficiency can be found under the sectional 'Operational Performance Summary'.

Cause of Exceedance(s):

WWTP upgrade required to meet ELVs (INC1018419).

Significance of Results:

The WWTP is non compliant with the ELV's set in the Wastewater Discharge Licence. The impact on receiving waters is assessed further in Section 2.

Significance of Results:

The WWTP discharge was not compliant with the ELV's set in the wastewater discharge licence for the following: BOD, 5 days with Inhibition (Carbonaceous) mg/l, ortho-Phosphate (as P) - unspecified mg/l.

The ambient monitoring results do not meet the required EQS at the upstream and the downstream monitoring locations. The EQS relates to the Oxygenation and Nutrient Conditions set out in the Surface Water Regulations 2009.

Based on ambient monitoring results a deterioration in BOD, Ammonia & Ortho-P concentrations downstream of the effluent discharge is noted.

A deterioration in water quality has been identified, however it is not known if it is or is not caused by the WWTP.

The Kildalkey agglomeration although listed on Cycle 2 as a significant pressure has been removed from the list of significant pressures in the Cycle 3 Draft Boyne Catchment Report (HA 07). Other causes of deterioration in water quality in the area are unknown.

The discharge from the wastewater treatment plant does not have an observable negative impact on the Water Framework Directive status. The WFD status is moderate both upstream and downstream of the WWTP.

2.1.4 OPERATIONAL PERFORMANCE SUMMARY - KILDALKEY WWTP

2.1.4.1 Treatment Efficiency Report - Kildalkey WWTP

Treatment efficiency is based on the removal of key pollutants from the influent wastewater by the treatment plant. In essence the calculation is based on the balance of load coming into the plant versus the load leaving the plant. The efficiency is presented as a percentage removal rate.

A summary presentation of the efficiency of the treatment process including information for all the parameters specified in the licence is included below:

Nominal design capacities can be based on conservative design principles. In some cases assessment of existing plants has shown organic capacities significantly higher than the nominal design capacity. Accordingly plants that appear to be overloaded when comparing a collected peak load with the nominal design capacity can be fully compliant due to the safety factors in the original design.
