

AA SCREENING DETERMINATION

Of

069 Lough Egish Water Supply Zone, Lead in Drinking Water Mitigation Plan, Co. Monaghan.

In accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and Regulation 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended, Uisce Éireann has undertaken Appropriate Assessment screening to assess, in view of best scientific knowledge and the conservation objectives of the site, if the project, individually or in combination with other plans or projects is likely to have a significant effect on European Site(s).

The proposed project involves the installation of an Orthophosphate dosing unit at Kilkitt Water Treatment Plant. The proposed project includes the installation of banded phosphoric acid storage tanks, housed dosing installations and associated works within the site boundary of Kilkitt Water Treatment Plant. The scope of the operational works includes the dosing of Orthophosphate to treated water at Kilkitt Water Treatment Plant.
