PR029 Requirements Update

UÉ's Minimum Requirements for Health, Safety, Quality and Environment on Uisce Éireann Capital Projects and Programmes document PS-HS-PR-029 has been updated. Some key updates made are the following

- Two new Golden Rules Pipe Deliveries and Pressure Energy
- Clarification on what is classified as a lower risk and higher risk excavation
- Updated mandatory requirement for Work Supervisor's is now the UÉ Work Supervisor **Training Programme**
- Allowance for remote supervision
- **Quality Section**

UÉ Work Supervisor Training Compliance

The Uisce Éireann Works Supervisor Training Programme was launched in January 2025.

This programme is now the only training that satisfies the Work Supervisors requirement under the latest version of PR-029 (Rev 3).

Any existing training completed, that would have complied with Rev 2 prior to this change, will be accepted until its expiry date but for all new training from the date of issue of Rev 3, the UÉ Work Supervisor Training Programme must be utilised.

Evidence that a Works Supervisor has been enrolled into a future UÉ Works Supervisor Training Programme, will be accepted as a minimum training requirement until June 30th 2025. A Training Programme Certificate of Completion will be required beyond June 30th 2025.

A gap has been identified around compliance with this training requirement. We would ask that you please review compliance within your own organization and schedule training for Works Supervisors, as required.

Please cascade this message to any subcontractors who may dispense the role of Works Supervisor on your sites.

The training programme is publicly funded from The European Social Fund (ESF+) under the Skills to Advance Scheme and will be open for bookings in mid-January. The training will be provided by Mount Lucas, the National Construction Training Campus.
